Call to Order

Board President Bob Schwab called the meeting to order at 5:30 P.M.

Roll Call

Present: Andy White, Maria Gomez, Bob Schwab, Wayne Finke and Eric Totemeier. Also, present Gary Benda, Neil Mills, Brett Nitzschke (legal counsel), the press and members of the community.

Andy White made a motion to approve the agenda. Seconded by Maria Gomez. Motion carried 5-0

Andy White led the Pledge of Allegiance.

The mission and vision statements were read by Eric Totemeier.

Andy White made a motion to go into closed session at 5:39p.m. Seconded by Wayne Finke. Roll call vote all yay. Motion carried 5-0.
